TERMS AND CONDITIONS

A. Application, Application Fee (non-refundable) and Placement

- A child will be <u>considered for placement</u> in Saint International School after completing the Application for Admission form, paying the Application Fee and providing all the documents required in the attached Checklist.
- Acceptance of a child is at the absolute discretion of Saint International School without having to provide any reasons whatsoever for its decision.
- Placement of a child is generally determined by the child's age in accordance to the "Year Group Placement" schedule and/or the entrance
 test and/or the interview at the sole discretion of the Principal or Registrar. The results of the entrance test and/or the interview are
 strictly confidential and shall not be made available to the child/parent/guardian.
- The Application Fee which is paid together with this Application for Admission form, is *non-refundable*, regardless whether or not Saint International School accepts and/or enrols the child into Saint International School.

B. Enrolment Fee, Deposit and First term's Tuition Fees (where applicable)

- Upon Saint International School's acceptance of the child to Saint International School, and to confirm reservation of a place, payment must be made for the **non-refundable Enrolment fee** to Saint International School within 14 days from the date of the school's acceptance letter, but in any case, before the first day the Pupil's class's start at Saint International School.
- The Deposit shall be refunded, less deductions made for any outstanding fees or any other charges/payments due, including but not limited to in the following circumstances:
 - a. at the end of a Term, provided the parent(s)/guardian(s) has/have provided **ONE FULL TERM'S** prior written **NOTICE** to Saint International School of their intention to withdraw the Pupil, together with payment of one (1) term's Tuition Fees. For Example, If a Pupil wishes to leave Saint International School at the end of Term 3, written notice must be given by the final school day of Term 2 together with payment of the following term's full Tuition Fees.
 - Failure to provide sufficient notice and/or the aforesaid payment, will result in the forfeiture of the Deposit at the sole and absolute discretion of Saint International School. Even in the event of a child's long term absence, ONE FULL TERM's prior written NOTICE together with the aforesaid payment is still applicable; or
 - after completing Year 11
 Saint International School reserves the right to wholly forfeit the Deposit where Saint International School terminates the enrolment of the Pupil for any reason which Saint International School, at its absolute discretion, deems fit.

C. Tuition Fees and payment terms

- All **Tuition Fees** (non-refundable) must be paid before the commencement of each Saint International School Term (there are 3 Terms in a year).
- Saint International School reserves the right to impose a late payment charge of 1.5% per month on all outstanding Fees and charges/ payments (as set out in Sections A and B herein) which have not been paid by the 15th day from the commencement of each Saint International School Term.
